If entry limits are exceeded you will be notified and placed on a waitlist. Start times will depend upon entries received. Cancellations with a full refund will be accepted until the end of the day of May 25th. The running order will be drawn and posted shortly thereafter.

Learning trial format will be determined by the number of entries, followed by a bbq and a group discussion/q&a. Please bring a dish to pass, hot dogs and hamburgers will be provided.
