

Update to the Flying Bucket Farm's Novice SDT!

The weather is looking great for the trial.

Running Orders are posted up on the NEBCA site ! Good Luck to all!.

PARKING: Due to the constant wet weather, we have had to decide to not let RVs stay in field. We have some alternative sites to have you park and camp out at...

RV'S AND CAMPERS: We will have you park on Blank Rd, which is a left at the stop sign on Harder Rd. This road is currently closed. So, although you will be on the road, there will be very minimal traffic. There are only two residences and then the random delivery trucks that need access via the road.

We have permission from the town's highway supervisor, Paul Dwyer, for campers to be on Blank Rd. If you encounter any difficulty from anyone about being there, please call Anya Varrone at (585) 478-7060

Bob Nilsson has some spots for RVs if you are not comfortable parking on the road. No hookups, plenty of space for dogs to run around, solid ground. \$25 per night. (585) 991-8546

ARRIVAL TIME: 12 pm – 6 pm

Arrival to the farm on Friday for rv's and campers is between 12pm and 6pm. We will be available to help you park and set up on the closed portion of Blank Rd during those hours. After 6pm, it's bedtime for the farm and you will be on your own. There is a Walmart in Geneseo, NY where you can park and wait.

If you need help or directions when you're in the area, or overnight if you are in an RV and need urgent help at any time, please text or call Anya Varrone – farm owner at (585)478-7060.

If you need emergency assistance call the county sheriff at (585)243-7100. Dialing 911 takes longer here as they have to refer you through other emergency departments.

GETTING HERE:

PLEASE NOTE: BLANK RD IS CLOSED. YOU MUST ACCESS HARDER RD FROM FEDERAL RD. Your gps may ask you to turn on Adams Rd or come up Rix Hill Rd depending on which way you are coming. Both roads will have you ending up at the closed Blank Rd. You have to take Federal Rd to Harder Rd. There will be signage at Harder Rd and Federal Rd.

FOLKS WITH MOBILITY ISSUES: If you need help getting from your RV to the trial field, or from either parking area to the trial field, we will have a vehicle available to shuttle you and your dogs and what you need for the day. Please call or text (585)478-7060 to set up a ride to the trial field if you need one. Please make sure to do this WELL IN ADVANCE of your run.

DAY OF TRIAL PARKING:

If the field gate is closed, please park on road, it means we're too soggy to drive on the field.

IF THE WEATHER IS DRY(and field gate is open):

Field parking for cars and trucks will be available on the left side as you come down Harder Rd, around the curve and just past the big Christmas trees. The entrance will be clearly marked.

DO NOT drive past the parking markers in the field, there are springs and wet spots and YOU WILL GET YOUR VEHICLE STUCK.

IF YOU PASS THE MARKERS, TOW OUT WILL BE AT YOUR OWN EXPENSE.

If you are coming day of trial in a large vehicle such as a camper or towing a trailer, please pull over and see the parking manager when you arrive, he will determine if you can park in the field or should remain on the road. If you cannot locate him please call (585)478-7060.

Those attending the trial with mobility issues or handicap plates may park in the gravel barnyard, the driveway is located across from the white mailbox. If you are unsure, please text or call (585)478-7060 and we'll sort you out.

IF THE WEATHER IS RAINY/WET:

We ask that you park along the road next to the field, please only use the one side of the road. we do not want you getting stuck, our ground saturates and becomes soft quickly. If rain is called for during the day, you may want to just park along the road or you may have to move your vehicle mid-trial to avoid getting stuck. If the field gate isn't open, park on road, it means we're too soggy for vehicles to park.

PLEASE DO NOT run your dogs on non-farm property. If it is not fenced, it is not ours to use. Friday evening, Saturday night after the trial, and Sunday night after the trial, you may run your dogs in the field along Blank Rd and Harder Rd. MAKE SURE TO CLOSE THE GATE WHEN YOU ARE DONE, THERE WILL BE LIVESTOCK IN THERE DURING THE DAY.

Guests of the Nilsson Residence, across Blank Rd will also be using the field to run their dogs in the off hours. Please be aware of one another to avoid dog conflicts. If you need to walk your dog during “livestock” hours in the field, you may use the grass along our side of the road. You may also use the yard at the Nilsson residence across Blank Rd, but you **MUST PICK UP AFTER YOUR DOG**. There will be a trash can on the corner for waste bags and trash.

PLEASE CALL Anya Varrone (585)478-7060 upon arrival if you are unsure of where to park or need any help or information.

FOOD: will be available for breakfast & lunches for a small fee – SATURDAY: Egg wraps/sandwich, yogurt, apples, bananas, coffee, Orange Juice & water. SATURDAY LUNCH - mini subs, walking taco, nachos & cheese / salsa, pasta salad, cookies, brownies, chips,soda, iced tea, lemonade. SUNDAY: Egg Wraps or Sandwich, donuts, muffins, yogurt, apples/bananas, coffee, tea, water. SUNDAY LUNCH: hot dogs, mac n cheese, pasta salad. Nachos with cheese/salsa, water, soda, iced tea or lemonade.

There will be very limited seating behind the handler’s post for viewing of the trial.
