Enter through gate at the end of the driveway to the right, follow the track to handler parking in the training field (see map below). **Warning: gate into trial field may have electric wire running across the bottom. Use plastic handle to open and close wire as needed to enter parking area.**

Start Time both days: 7:30 AM handlers meeting followed immediately by first handler at the post.


